- **ARRIVAL TIMES IMPORTANT! All Trailer Vendors (if you sell from your trailer) and Food Vendors should arrive between 4:00AM - 5:00AM.** Trailers not entering by 6:00am may forfeit your spot and access to electricity. Please observe this time change format. All regular (tent) booths may begin set up between 5:00 AM-8:00AM no vehicles will be allowed on the square after 8:00AM on Saturday. This is to allow the trailers easier access to their spots.
- Festival hours- **Saturday 9:00 AM - 4:00 PM** (We ask that vendors remain until 4PM, no vehicles on the square until all pedestrians are gone)
- Your booth is NOT reserved until we receive your registration fee. Make check or money order to: **FCC/CF Vendor.**
- Rain or Shine Event. **All Fees Non-Refundable / \$50.00 charge on all return checks.**
- Money order, cash, or credit cards only after August 30, 2024.
- All merchants must provide their own tents, tables, chairs, AND ELECTRIC CORDS-Rest rooms and trash cans will be available on site.

**\*\*\* Trailer Vendor Fees Example:**  
 If you are a trailer vendor or food truck and you need electricity, you should pay a Trailer fee **(Tongue to Tail)**  
**EXAMPLE:** an 8 x 16 = 128 sq ft trailer (128 x 1.00=128.00 trailer fee) would be the following: \$128.00 + 40.00 (electric) for a total of \$168.00
